Fire Service Partners,

A study conducted by the National Institute for Occupational Safety and Health found that firefighters have a 9% greater risk of being diagnosed with cancer and a 14% greater risk of dying from cancer than the general public (<a href="https://blogs.cdc.gov/niosh-science-blog/2017/05/10/ff-cancer-facts/">https://blogs.cdc.gov/niosh-science-blog/2017/05/10/ff-cancer-facts/</a>).

The Volunteer Firefighter Enhanced Cancer Disability Benefit Law (NYS General Municipal Law 205-cc) provides benefits for eligible firefighters diagnosed with cancer and includes reporting requirements for fire departments.

The link also provides access to cancer awareness and prevention information for the fire service to raise awareness and reduce the cancer risks firefighters are exposed to.

To assure all eligible firefighters are aware of the Law and the benefits provided, I encourage all fire departments to review this information with their members.

I encourage fire departments undertake concerted efforts to implement cancer awareness and risk reduction programs. The Office of Fire Prevention and Control is available to assist with and support these efforts.

There have been changes to the Law to help fire departments provide coverage to firefighters who entered service prior to January 2020. These changes allow firefighters to meet eligibility requirements by allowing alternative documentation of eligibility requirements including five years of interior firefighter status and that the required physical examination has occurred.

For firefighters who entered service after January 2020, the original eligibility requirements apply:

1. the volunteer firefighter was an active volunteer firefighter as of January 1, 2019;

- 2. the volunteer firefighter has 5 or more years of service as interior firefighter;
- 3. the volunteer firefighter has successfully completed a physical examination, prior to the commencement of duties as an interior firefighter, which failed to reveal any evidence of cancer; and,
- 4. the volunteer firefighter has passed 5 yearly fit tests.

**Due by December 1, 2022,** Fire District, Department or Company Annual Claims Report EOSB - 210.8 C. Your insurance company can provide a report that includes this information.

**Due By December 1, 2022,** Annual Roster of Interior Firefighters EOSB - 210.8 R. This should include the list of a department's interior firefighters from 2022.

**Due by January 1, 2023,** Volunteer Firefighter Enhanced Cancer Disability Benefits Program Attestation / Proof of Benefits EOSB - 210.5, along with a copy of the cover sheet of the insurance policy

Certification of Eligibility (ESOB 210.4) Due upon a diagnosis of cancer of an eligible firefighter. Certification of Eligibility is to be sent to the coverage provider (AHJ or Insurance Company) NOT OFPC.
